Interest on Drawings = Total Drawings x Rate x  $\frac{\text{Average Period}}{2}$

Interest on A's Drawings =  $(4,000 \times 6) \times 5\% \times \frac{(6 + 1)}{2} \times \frac{1}{12}$   
= ₹ 350
